The matters alleged in this Complaint are not the subject of civil or criminal litigation, to the knowledge of the Complainant.

Violation 1: Illegal corporate donations

Article VIII, Section 23(3)(a) of the Missouri Constitution prohibits corporations from donating to candidate committees. During the 2024 election cycle, Eigel for Missouri has accepted two donations from corporate entities:

- \$2,500 from Warrenton Oil Company on 8/16/2021
- \$750 from Statt, Inc on 6/29/2023

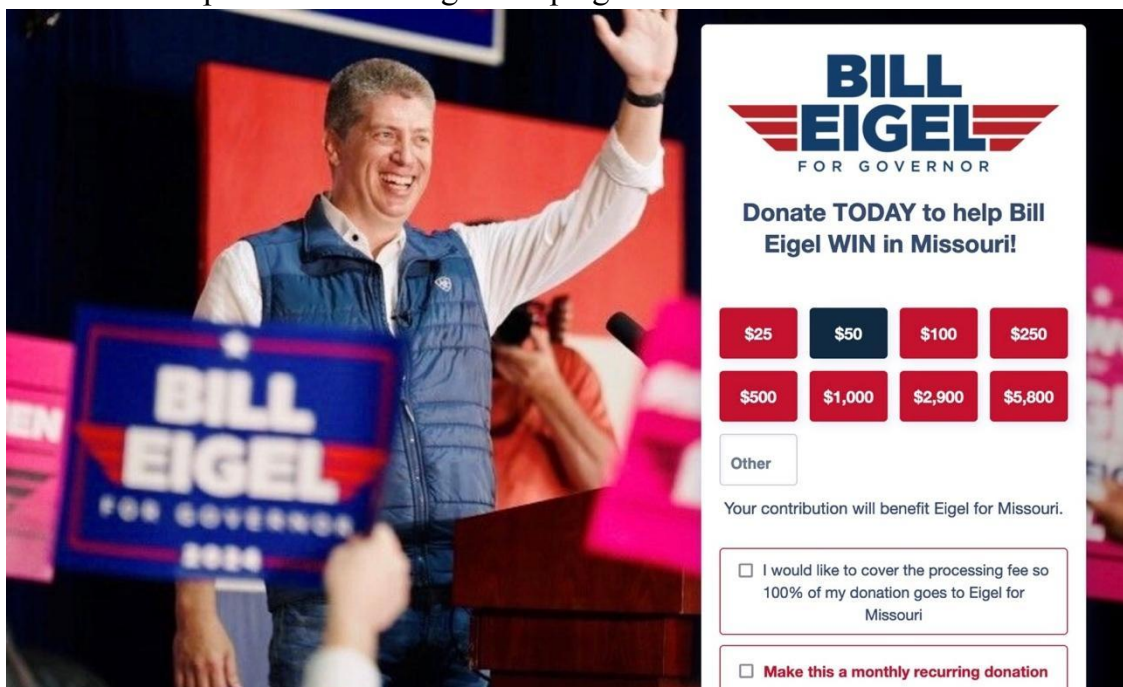
Neither of these donations have been reported to be returned to the contributor. As such, acceptance of these donations is a violation of the Missouri Constitution.

Violation 2: Soliciting over-the-limit contributions

The Missouri Constitution and the Revised Statutes of Missouri limit the amount of money that individuals may donate to candidates for statewide office. Effective January 1, 2023, candidates for the office of governor may accept contributions of up to \$2,825 per contributor.

Eigel's campaign website currently encourages visitors to donate amounts up to \$2,900 and \$5,800, both of which exceed Missouri's per-person and per-couple limits.

Violation 3: Inaccurate reporting of contributions

Eigel's April 2023 report shows numerous individuals who purportedly made multiple donations for the same amount on the same day. By way of example:

- David Cort was reported to have made two donations of \$1,041.02, both on 1/31/23
- Randall Schilling was reported to have made two donations of \$500, both on 2/16/23
- Kevin Kast was reported to have made two donations of \$500, both on 3/8/23
- Josh Grasser was reported to have made two donations of \$260.25, both on 3/28/23

In total, 115 entries out of the 268 itemized donations listed on Eigel's April report appear to be duplicates. Such a pattern is highly unusual and improbable. This is almost certainly a reporting error, which had the effect of increasing the amount of Eigel's reported receipts for the quarter by as much as \$14,905.64.

A list of all apparently duplicate donations is provided in Appendix 1 of this complaint.

Summary

Taken together, these errors show more than sloppy and inaccurate record keeping and reporting. They suggest a fraudulent attempt inflate the amount of Eigel's contributions by tens of thousands of dollars, thereby artificially boosting its publicly-reported cash-on-hand figures and providing Missourians with an inaccurate picture of Eigel's fundraising.

I request an immediate investigation into the violations described above and any other issues that may arise during the course of the review.
