**SUMMARY/NARRATIVE**

It is the opinion of this firm that had Eigel had any major opposition research done on him, he would NOT have become a state senator in the first place in 2016. With the sheer amount of stupid things Eigel has done SINCE becoming a state senator, a person running against him, with the information in this packet and information that will undoubtedly come from his 2020 voting record in the MO Senate, will have more than enough negative bullets to hit him with and have a new senator represent Senate District 23 in St. Charles County. Here are the points we think an opposing candidate needs to hit him on:

1. While campaigning on a platform of cutting taxes, he's actually sponsored legislation to RAISE taxes, raising both gas taxes AND raising the sales tax, costing lower-income Missourians hundreds of millions of dollars/year.
2. Although he campaigns as a pro-lifer, he's taken \$3,000.00 from a group that supports embryonic stem cell research.
3. Although he represents himself as a smart, successful businessman, he's shown repeated irresponsibility in running his businesses, being sometimes years late in paying his personal property taxes, as well as getting slapped with a State of MO tax lien for failure to pay taxes due to the state.
4. Although rumors abound that the Humphreys and other major benefactors of his 2016 campaign are not with him for re-election, the fact remains that the Humphreys, the Sinquefields and the Herzogs ALONE make up more than 51% of the donations to his political campaigns.
5. He'll claim that he was abiding by "conservative" ideals in voting against these, but in his quest to grab headlines and attention, he's gotten a reputation as a trouble maker, someone who is not interested in seeing that government runs properly, and voting against budget bills that fund BILLIONS for roads, education, seniors and veterans, highway patrolmen, and other needed services.
6. Eigel employed Carter Ballman to help run his campaign, who wound up being sentenced to 5 years in prison for trying to solicit sex from a 14-year-old while working for a state representative in the Capitol in Jefferson City.

7. Eigel is soft on crime, voting against funding for highway patrolmen, voting against a prescription drug registry to combat drug addiction, and voted against tougher laws to keep predators from having access to vulnerable senior citizens.

Eigel gives an opposing campaign so much to work with, it'll be hard to decide which things to use. I have faith, though, that there will be a campaign that will put this to effective use and send Bill Eigel packing in the election next year.

Senator William C. (Bill) Eigel, was sworn into office on Jan 4, 2017, to serve the residents of Missouri's 23rd Senatorial District in St. Charles County. Senator Eigel is a United States Air Force military veteran of eight years and has owned a small business in St. Charles County for more than 10 years.

Senator Eigel, who held the rank of Captain while serving in the Air Force, completed assignments in Louisiana, Arizona, and most recently at Whiteman Air Force Base, Missouri. He is a decorated veteran for service overseas in support of Operation Enduring Freedom, as he was awarded commendations for his service in Ashgabat, Turkmenistan.

After leaving the service in 2006, Sen. Eigel purchased St. Louis Skylights, a small residential and commercial remodeling company. Despite the challenges of the economic recession in 2008 and 2009, St. Louis Skylights was renamed to National Skylight Solutions in 2010 as it grew to service all areas of the United States. With permanent locations in Missouri and Illinois, and serving customers in all 50 states, National Skylight Solutions (and affiliates) is one of the fastest growing skylight installation companies in the country.

Senator Eigel is a member of Veterans of Foreign Wars, the National Rifle Association, and is a volunteer for the Missouri Veteran's Retirement Home in North St. Louis County. Senator Eigel lives in Weldon Spring with his wife, Amanda, and their two children. They are all members of St. Joseph's Catholic Parish in Cottleville, Missouri.



### **ABSENTEEISM**

1. Eigel has missed 32 floor votes since becoming a MO Senator:
  - a. 2017 – 3
  - b. 2018 – 28
  - c. 2019 - 1
2. Eigel was absent for 38 of 73 (52%) of the votes of the 2019 MO Senate Fiscal Oversight Committee.
3. Eigel was absent for 6 of 29 (21%) of the votes of the 2019 MO Senate Health and Pensions Committee

**AGRICULTURE/ENVIRONMENT**

1. Voted against funding for the MO Department of Agriculture and the MO Department of Natural Resources; was the ONLY senator to vote against this funding in 2019 (SCS HCS HB 2006, 4/25/2018; CCR & CCS SCS HCS HB 6, 5/9/2019) The 2019 legislation funded:
  - a. \$1.8 million for the Agriculture Business Development Fund to help market wines and grapes that come from Missouri, including from wineries in St. Charles County. (Section 6.030)
  - b. \$5.1 million for funding for the MO State Fair (Section 6.120)
  - c. \$100,000.00 for the cleanup of controlled substances, such as meth labs (Section 6.225)
  - d. \$26.3 million to reduce water pollution (Section 6.225)
2. Voted against allowing the growing of industrial hemp in MO (SCR 9, 4/12/2017)
3. The ONLY senator to vote against an additional \$1.7 million for the Division of State Parks for repairs to trails, exhibits and a list of related things associated with state parks (HCS HB 2019, 5/11/2018)
4. The ONLY senator to vote against an additional \$33 million for the Department of Conservation for improvements to wetlands, roads in conservation areas, and other conservation related improvements. (HCS HB 2019, 5/11/2018)

**BUSINESS ISSUES**

1. One of only 5 senators to vote against allowing the Department of Economic Development to offer certain companies tax credits in an amount equal to or less than nine percent of new payroll if such company creates ten or more new jobs and the average wage of new payroll equals or exceeds 100% of the county average wage, thereby creating an incentive for job creation. (HCS SB 68, 5/9/2019)
2. Voted against funding for the MO Department of Transportation (HCS HB 4, 4/24/2019) This bill funded:
  - a. \$1.2 billion for road construction statewide (Section 4.410)
  - b. \$301 million for repairing 215 bridges statewide (Section 4.425)
  - c. \$396 million for road maintenance statewide (Section 4.435)
  - d. \$10.6 million for transportation programs for the elderly and the disabled statewide (Section 4.475)
3. Voted against funding for the MO Department of Economic Development (SCS HCS HB 2007, 4/25/2018) This bill funded:



- a. \$2.25 million for business recruitment and marketing to states and countries around the world (Section 7.025)
  - b. \$2 million for the State Small Business Credit Initiative (Section 7.050)
  - c. \$77.9 million for job training programs for those who find themselves unemployed, including those who lose their jobs due to unfair trade practices (Section 7.115)
  - d. \$46.951.00 to enforce child labor laws (Section 7.820)
4. Eigel supports Right to Work legislation, which could be a hot button issue in the union-heavy north side of his Senate district. (<https://themissouritimes.com/35186/eigel-poised-become-strong-business-advocate-senate/>, 11/15/2016) It was a heated topic during his 2016 primary against Rep. Ann Zerr, a leading Republican proponent of labor issues. The primary became incredibly contentious and Eigel beat Zerr by just under 400 votes, winning roughly 40 percent of the district (Michael Carter received about 21 percent, Zerr took home 39 percent). 5. Eigel suggested the Conservative Caucus would block Parson’s job-creation programs, including an adult college scholarship proposal, a revamp of the Department of Economic Development and two bills that he said would streamline the agency’s ability to lure businesses to Missouri. 6. Eigel, Onder, Sen. Andrew Koenig and others had held up the Parson’s Fast Track scholarship program because Senate leadership would not allow the group to add an amendment that would create what are known as Education Savings Accounts.

That proposal would more easily allow families to send their children to private schools, which critics fear would harm the public-school system. **This move potentially put General Motors \$1 billion investment to its Wentzville plant in danger.**

Terrible Business Practice

The short story is that I signed the contract and waited a long time for them to schedule me, only to be cancelled. The reschedule time was ridiculous, I decided this company would not be very reliable if I had water leakage. If they could not get around to installing my sun tunnel, how long would it take them to get around to fixing a water leak or some other damage. Now they want me to pay a \$192.50 restocking fee or they are going to put a lien on my house. Very uncool business practice. They have my \$192.50 and a bad review.

In April 2017 Sam came to my house to give me an estimate. He was very professional and thorough. I did not sign the contract at that time because I was getting quotes from their competitor. Sam followed up monthly with a phone call. In early June I signed and mailed in the contract. I chose this company because they were professional and I felt I would not have to worry about any warranty work should I have leaks from a sun tunnel.

6/14 Tony left me a message letting me know that he got the contract and would contact me to schedule something in 4-6 weeks.

7/12 Tony left me a message letting me know that they are behind schedule, due to a heat wave, and would call back to reschedule.

8/4 Tony and I spoke and scheduled an install for 8/23

8/23 Tony called me in the morning to cancel the install. His installer was injured. He would call back to reschedule. (I had taken the time off of work to be at the house for the install - I am now out a day's wages).

9/5 Tony calls and leaves me a message. They have had a cancellation and would like to come that day to install. We work and cannot drop what we are doing to get to the house that day. My husband returns the call.

10/5 Tony calls and leaves a message. Want's to set up an install for 10/17.

At this point I have decided that this company clearly has no interest in coming out to install one lousy tube in a timely manner. This job is small and I am being shuffled around. I have a sour taste in my mouth about this and worry that if there was a problem with the tube - how long would it take them to get out to fix the tube. I have changed my mind and no longer want a sun tube in my house. I ignore his call.

### CONSUMER/FREEDOM ISSUES

1. One of only 5 senators to vote against requiring MO drivers' licenses to be REAL ID compliant, an eventual requirement for Missourians to have in order to be able to board an airplane or enter a federal building (SS#2 HCS HB 151, 5/9/2017) Eigel was also one of nine senators to sign a letter to Attorney General Josh Hawley urging him to fight the enforcement of federal law

requiring states to adopt uniform security procedures on government-issued identity cards, such as driver's licenses – known as the REAL ID Act.

2. Voted to remove limits to how much cities and counties can charge for minor traffic violations, potentially allowing cities to become speed traps again (SS SCS SB 553, 5/1/2018)
3. Voted for legislation that would scrap the Missouri Merit System for state employees and make most state workers at-will employees subject to political pressure (SCS SB 1007, 5/1/2018)
4. One of only two senators to vote against in committee legislation that would require all childcare facilities to disclose the licensure status of the facility to the parents or guardians of children for which the facility provides care. Also, it would increase the existing fines for persons who make materially false statements in order to obtain or renew a license from a fine not to exceed \$200 for the first offense to a fine not to exceed \$500 and from a fine of up to \$200/day for subsequent offenses to a fine of up to \$500/day. Additionally, the Department of Health and Senior Services may close any illegally operating unlicensed childcare facility upon documentation of the illegal status of the facility or the finding of an emergency based on the harm or imminent harm to the children involved, subject to statutory procedures for license suspensions and revocations. A local prosecutor may file suit for a permanent order preventing the operation of the facility that shall remain in effect until the court determines that the childcare facility is in compliance with all licensing requirements. Any operator of a facility closed under this provision that is later found to have been legal shall have the right to exercise any rights and remedies that may be available at law or in equity. (SB 115, 2/28/2017)
5. The ONLY senator to vote against creating within the MO Department of Economic Development to administer giving grants of up to \$21 million/year to expand broadband Internet coverage to areas that either don't have broadband Internet at all or are under-served. (SS HCS HB 1872, 5/17/2018)

6. Voted against making disposable diapers eligible to be a tax-free purchase during the August back-to-school sales tax holiday; potentially a \$1 million tax break for families with newborns (HB 1831, 5/18/2018)
7. In a potentially unpopular opinion, even though Ameren petitions the MO Public Service Commission for rate increases constantly, Eigel praised electricity utility provider Ameren Missouri. He feels that they can be trusted “because of his personal experience,” further stating “I’ve gotten to know Ameren pretty well: I’ve toured their facilities, I’ve heard about their plans about what they want to as far as restructuring the utilities environment and they’re a great partner for us. They want low rates as much as we want low rates for our customers and consumers.”

8. Eigel was the ONLY senator in committee to vote to continue to allow schools and employers to demand from students and employees, respectively, the passwords to their social media accounts (SB 316, 3/1/2017)

### CRIME

1. Voted against setting up a prescription drug registry to combat prescription drug abuse (HCS HB 90 & 68, 4/3/2017, 4/13/2017; SS SB 74, 3/2/2017)
2. One of only 3 senators to vote against making it a Class D Felony for any employee of a law enforcement agency, while on the job, to have sexual contact with a witness in a case their agency is handling, or anybody that is detained by their agency (SS SCS SB 996, 4/5/2018)
3. Voted against funding for the MO Department of Corrections (SCS HCS HB 2009, 4/25/2018; CCR & CCS SCS HCS HB 2009, 5/9/2018) The 2018 bill funded:
  - a. \$75,278 in payments to those who were wrongly convicted (Section 9.030)
  - b. \$17.6 million for the NE Correctional Center in Bowling Green, MO, where lots of people from St. Charles County drive to work every day (Section 9.170)
4. One of only 2 senators to vote against putting into law that firms in the home health industry and in-home care services shall be guilty of a Class A misdemeanor if they employ a person who is guilty or has pleaded guilty or nolo contendere to certain offenses, is on the Department of Health and Senior Services' employee disqualification list or the Department of Mental Health's

employee disqualification registry, or has a finding on the child abuse and neglect registry (SS SCS HB 1350, 5/8/2018)

5. One of only 3 senators to vote against creating the offense of filing false documents. For the first offense, filing a false document is a Class D felony, but can be a Class C felony in certain specified instances. Any person who is found guilty of filing a false document shall be ordered to make full restitution to any person or entity that has sustained any actual losses as a result of the filing, such as a false police report. (SS SCS HB 1769, 5/8/2018)
6. Carter Ballman, who helped run Eigel’s winning 2016 campaign and later served on his staff, was arrested in the Capitol after trying to arrange a sexual encounter with a 14-year-old.

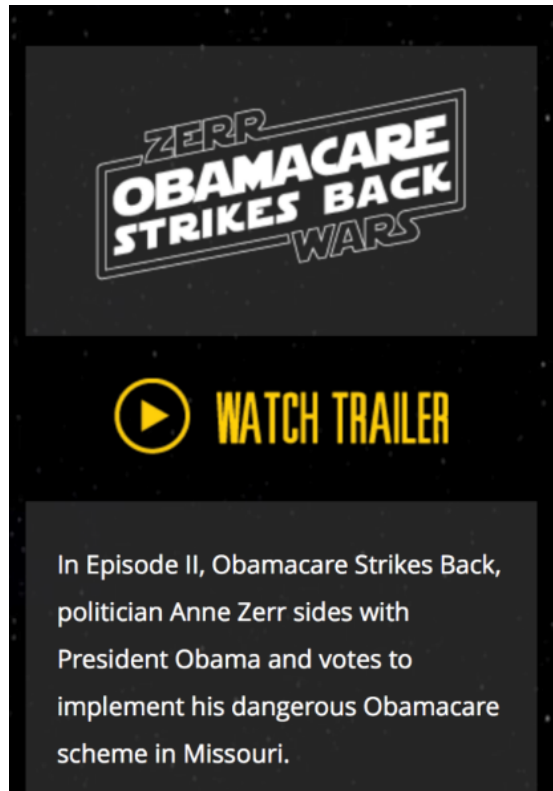

27. One of Eigel’s primary opponents, Mike Carter, criticized Eigel for recently moving to the district and made comparisons to him being a “carpetbagger.”
- i. “Having lived in Missouri Senate District 23 for twenty-two years, Mike Carter is well aware of all the great things SD23 has to offer. "It's an amazing place to live and a great place to raise kids. I've lived here a very long time and am proud to call it home," Carter said. Carter has also owned and operated his law firm, Carter Law Offices, in the heart of the district since 2004.
  - ii. For all these reasons, Carter is happy to welcome Bill Eigel to the community with open arms. "Bill's new around here. He moved into this district very recently and I'm sure he'll grow to love it just as much as I do."
  - iii. Eigel purchased his Weldon Spring home one year ago today, and some are concerned that his unfamiliarity with this particular district isn't a good thing. Like any other place, SD23 has problems unique to the district and a collective voice all its own. Many feel that someone new to the area might not be aware of the particular needs and demands of the district's constituents.
  - iv. Similar concerns arose during the 2000 US Senate race in New York when Hillary Clinton purchased a house in Chappaqua, New York barely a year before the election in order to run. Clinton was labeled a carpetbagger and was accused of being opportunistic and not really caring about New Yorkers.
  - v. So how similar are Hillary and Eigel? "I don't know about that," Carter commented. "I care about the needs of the people in this district, and I know what

those needs are because I live here and have gotten to know the other members of this community in my many years here. I can't speak for Mr. Eigel or what he cares about. All I can speak to is what motivates me.”

### **TAX AND FEE INCREASES**

1. Eigel has stated of his political priorities: “I am passionate about cutting taxes. I don’t like high taxes... 2. However, he sponsored legislation to increase the state sales tax from 4.225% to 6.225%; albeit also lowering the state income tax from 5.5% to 4% over time. The sales tax increase would increase state revenues by \$1.46 BILLION annually; the decreased income tax revenue would be lowered by \$1.1 billion, resulting in a NET tax increase of \$375 million/year (SB 52, 2019) Eigel presented SB 52 to the

Senate Ways and Means Committee, which aims to transition Missouri away from an income tax to a consumption tax in a revenue neutral way (It's NOT revenue neutral, by the way. But the problem, according to one opponent, is that the bill in its current form is a tax increase on Missourians making \$100,000 or less. "As of right now, it impacts low wage workers more than probably intended," said Brian Colby with the Missouri Budget Project. Another person who testified against the measure noted that "from a business perspective, it is not revenue neutral," while another said that since Missouri is not in a growth mode, "it is time to put a pause on tax cuts." Under Eigel's proposal, the state sales tax would increase 2 percent from 4.225 percent to 6.225 percent while slowly decreasing the top individual income tax to 4 percent.

MERA will make Missouri the second-lowest income tax state of any of our neighbors—lower than Illinois, Iowa, Kansas, Nebraska, Arkansas, Oklahoma, and Kentucky. There's no better incentive for business owners to come to Missouri than more of their own capital."   - a. It would have taxed sales in Missouri that were conducted on the Internet, and experts say that at least \$210 million/year would be collected additionally each year.
  - b. It would have increased the gas tax by 6 cents/gallon per year by 2023, which would have increased state tax revenue by \$252 million/year.

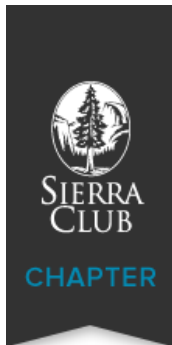

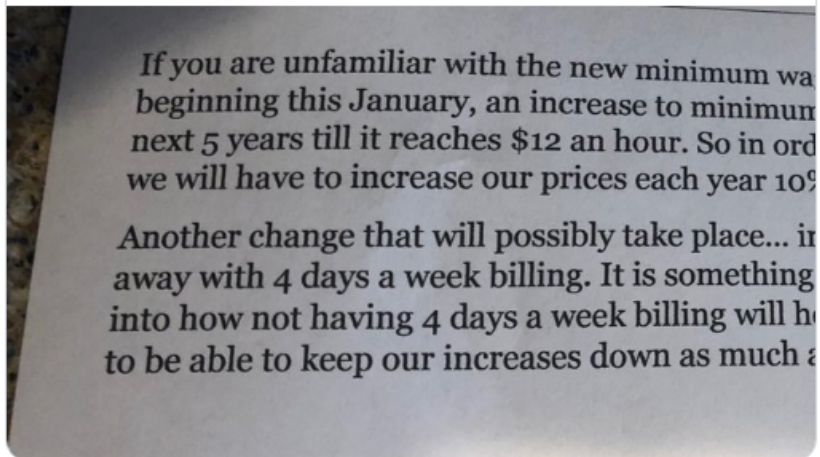

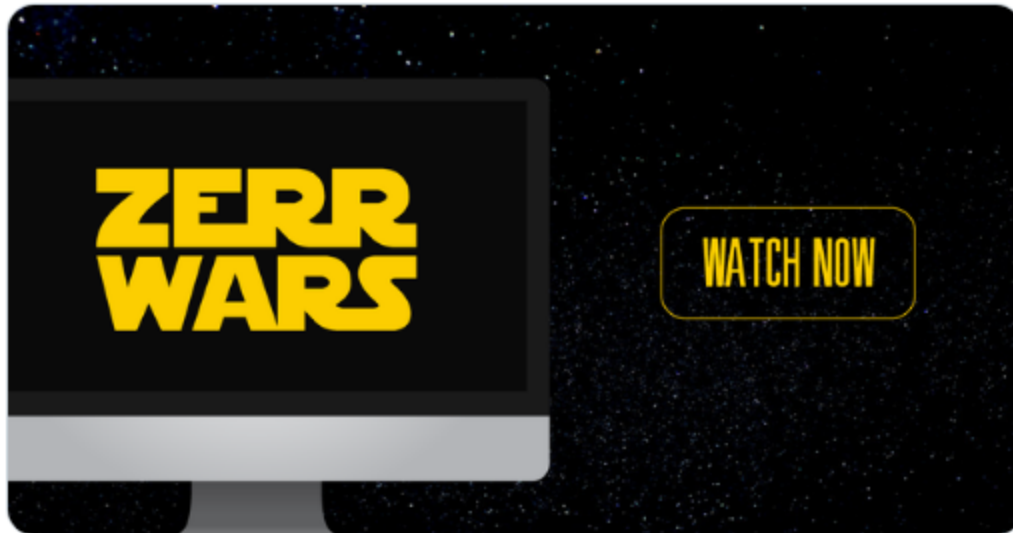

There is a new champion for the ultimate regional example of government waste in St Louis, and it is the Loop Trolley boondoggle occurring over in St Louis County and City. The reality of this waste truly boggles the mind.

Consider: since this whole mess began back in the 2012ish timeframe, St Louis County residents and American citizens at large (since federal dollars have been used) have spent a grand total approaching .... \$51 MILLION... for the Loop Trolley.

All this cash has bought a trolley that runs a 2.2 mile loop from the Missouri History Museum to University City. For those counting, that's nearly \$4,400 per FOOT of loop trolley decadence! All this cost has produced an asset that produces about \$40,000 per year in gross revenue from ticket sales. Or, in keeping with my theme, it produces about \$3 per FOOT each year. The Loop Trolley may go down as the greatest example of government waste we've seen in the Gateway City. This is why I'm hesitant about the growth of government in other sectors of our state. Government does very few things well or efficiently. We are better off letting the free market decide winners and losers in commercial enterprise, not government special interests.

Many of my constituents have asked about the \$50 million tax incentive proposal being considered for General Motors to expand on their plant in Wentzville.

Here is what I think:

1. I don't support benefits that go to one company or group and not another. I'm thrilled that GM is thinking of making a bigger investment in St Charles and I think they have a lot of reasons to do so. But there are a lot of small and medium businesses in St Charles that aren't getting millions of dollars to risk their investments here. How is giving GM special dollars fair to them?
2. There's a lot more to like about St Charles than corporate handouts from Jefferson City. I've raised a family here and owned a small business here. I never got a dime from the government to do so. I don't regret a minute of it because St Charles is a great place to live. My wife grew up here. I've been here my entire adult life outside of military service. I'm insulted whenever I hear that St Charles is only being considered for investment because Jefferson City is offering a special deal. St Charles didn't become the fastest growing area in Missouri because of government programs and interests--we are a low tax, low regulation, business friendly county. We have economic opportunity, low crime, and a sense of community that transcends the activities of elected folks.
3. I'm still committed to creating the best possible environment for businesses to thrive here. If the current economic development programs already in place in Missouri can make investment more attractive to GM, then great, I'm all for it. But if it means expanding corporate welfare to accommodate one company, even one as big and with as much history in St Charles as General Motors, it's tough to see how I can support it. In 2008, Ohio gave GM \$82 million to incentivize the plant in Lordstown, Ohio. On March 19th of this year, GM closed that plant. Corporate Welfare can't move Missouri to prosperity.

I would like to hear my constituents stories and thoughts on this type of incentive. Do you own a small business in St Charles? Have you ever benefitted from these incentives? Do you live here? Do you want your tax dollars going for this type of incentive? Share your stories and thoughts here--next week we will debate this bill on the Senate Floor.

Yesterday two Republican State Senators, from Springfield and southern Missouri, decided to use the budget process to give unlawful immigrants the same subsidized tuition benefit of in-state Missouri residents.

This would lead to violations of the Illegal Reform and Immigrant Responsibility Act of 1996 which prohibits access to in-state tuition benefits by undocumented students (section 8 USC 1623). It reads "...an alien who is not lawfully present in the United States shall not be eligible on the basis of residence within a State for any postsecondary education benefit unless a citizen or national of the United States is eligible for such a benefit.."

In other words, folks who are here illegally cannot get a benefit that every other American is eligible for. Given that out-of-state students don't get the subsidized rate, illegal non-residents cannot qualify under this Federal statute.

I don't have a good answer as to why these two Republican Senators decided to break ranks with Republican policy on the protection of immigration statutes, but I will continue to defend our national immigration policy and support the rule of law.

The Conservative Caucus in the Missouri Senate will not allow this budget bill to pass into law without protections of our immigration policy that had been in place for years.
